1. Modified USEA rules apply.
2. This is designed to be a practice day, allowing riders to ride a dressage test and jump round in a friendly show environment. No awards to be given. Dressage tests will give comments but not be scored. **PRE-ENTRY REQUIRED** (in order for management to schedule rides and organize dressage tests). Because this show may be canceled due to inclement weather we ask that **riders pay day of show in CASH ONLY.** (No check, no Venmo, no credit card). Combined Test cost \$50. (\$40 for riders who board full time at CFE). Additional jump rounds will be offered at the end of each division for \$10 each.
3. All dressage tests will be in a 20 x 40 meter dirt arena. Dressage begins at 9:00 am. Jump test will begin after the final dressage test is completed. Jump test will be on dirt/synthetic blend ring. USEA Show Jump rules to apply. No time penalties will be calculated for the jump test. Indoor sand ring available for warm up as well as outdoor jump ring prior to dressage. Indoor ring available for warm up prior to jump rounds.
4. Very limited stabling on grounds. Please call Erika, 925-575-0804 at Cline Falls Equestrian. Show address: 170 NW 76th St. Redmond, OR 97756
5. **ABSOLUTELY NO DOGS** allowed on show grounds.
6. Ride times available after 5 pm on Thursday, March, 14th; call or text 541-771-2031.

Releasor desire to engage in equine activities sponsored by, or in which Releasor will be using equipment, facilities, and/or premises, furnished by Releasee. Releasor understands there are risks in equine activities, that all horse activities are inherently dangerous and agrees to comply with Oregon's Equine Inherent Risk Law ORS 390.687-30.697.

As a condition of participation in or viewing equine activities, Releasor (individually and for his/her minor children, executors and heirs) waives the right to bring and releases Releasee and Releasee's administrators, agents, officers, directors, employees, predecessors and successors-in-interest, and any other persons or entities united in interest with Releasee from any and all manner of actions, suits, claims for relief, demands, damages and any other obligations, known and unknown, suspected and unsuspected, in law or equity, direct or indirect and whether now or in the future, for any injury or death arising out of or connected in any way with riding, training, grooming, or handling an equine.

Releasor agrees that by using Releasee's facility, including barns, paddocks, arenas, pastures and jumps, he/she is participating in a dangerous sport and that he/she will be responsible for the safety of self and children or others in their party. The Releasor understands that Releasee requires safety helmets and boots with heels to be worn by all riders while riding on the property and showing in the Derby.

This release contains the entire agreement between the two parties hereto and the terms of this release are contractual, not a mere recital.
