1. Modified USEA rules apply. One horse/rider pair per division, no cross entry allowed.
2. Awards: Ribbons 1st thru 4th (If entries warrant, Junior Divisions will be offered.)
3. All dressage tests will be in a 20 x 40 meter sand arena. Dressage begins at 9:00 am. Jump rounds will begin after the final dressage test is completed. Jump test will be on grass and will include a combination of show jumps and cross country jumps (including water). Jump penalties will apply. No time penalties will be calculated for the jump test.
4. Very limited stabling on grounds. Please call 541-771-2031 to reserve a corral \$20 per day. Cline Falls Equestrian (2 miles) may also offer stabling call Erika, 925-575-0804.
5. **ABSOLUTELY NO DOGS** allowed on show grounds.
6. Ride times available after 5 pm on Wednesday, October 14th. Text 541-771-2031.
7. If management needs to cancel due to lack of entries, or state mandate cancels such activity, entry fees will be refunded less \$5.00 office fee.
8. Jump schooling will be permitted after the show (trainer must be present) \$25 per horse. Please see secretary for fee payment and schooling number at the end of Derby.

This Document Affects Your Rights in the Event of Injury

Releasor desire to engage in equine activities sponsored by, or in which Releasor will be using equipment, facilities, and/or premises, furnished by Releasee. Releasor understands there are risks in equine activities, that all horse activities are inherently dangerous and agrees to comply with Oregon's Equine Inherent Risk Law ORS 390.687-30.697.

As a condition of participation in or viewing equine activities, Releasor (individually and for his/her minor children, executors and heirs) waives the right to bring and releases Releasee and Releasee's administrators, agents, officers, directors, employees, predecessors and successors-in-interest, and any other persons or entities united in interest with Releasee from any and all manner of actions, suits, claims for relief, demands, damages and any other obligations, known and unknown, suspected and unsuspected, in law or equity, direct or indirect and whether now or in the future, for any injury or death arising out of or connected in any way with riding, training, grooming, or handling an equine.

Releasor agrees that by using Releasee's facility, including barns, paddocks, arenas, pastures and jumps, he/she is participating in a dangerous sport and that he/she will be responsible for the safety of self and children or others in their party. The Releasor understands that Releasee requires safety helmets and boots with heels to be worn by all riders while riding on the property and showing in the Derby.

This release contains the entire agreement between the two parties hereto and the terms of this release are contractual, not a mere recital.
